**10:20 Digital Forensics: Cell phones, Smartphones, and other Gadgets**

This presentation will provide participants with an overview of the latest use of items including Smartphones and other electronic gadgets, and the challenges they present to digital forensic analysis. The presentation will address specific issues related to such devices including the manner of the forensic search and the criminal use of BlackBerry devices connected to fully secure/encrypted domestic and offshore servers and the challenges/roadblocks that this presents.

The discussion will also include information about how such devices have become an integral part of the criminal's electronic "footprint" and what types of evidence can be discovered from the forensic analysis of such devices. Finally, it will provide participants with information about the considerations which need to go into presenting such evidence, the possible uses of it (inculpatory and exculpatory) and strategies for approaching this type of evidence.
