# Agenda

# Plenary Session: How to Prepare a Successful Cross-Examination

You will learn how a well-planned cross-examination will enable you to both minimize the impact of damaging evidence and elicit helpful testimony from your opponent's witnesses. Expert faculty will cover:

- When if ever should you NOT cross examine a witness?
- Tips on how to effectively identify what issues to cross on
- How to identify your objectives for the cross
- Sequencing the importance of recency/primacy-organization
  - where do you start?
  - where do you end?
  - what do you do in the middle?
- How to get your opponent's witness to work for you
  - using an adverse witness to your advantage

### Demonstration #1

Our expert faculty, with years of practice and instruction in the ITAW, will demonstrate an examination in chief, and cross-examination, with discussion to follow

Small Group Sessions – Part One: TOOLS of the TRADE – Advanced Questioning & Impeachment Techniques

Small group sessions will focus on techniques for overcoming potential pitfalls in cross-examination. Participants will perform and receive individualized feedback from faculty.

During the sessions, you'll practice:

- How to impeach the witness, the evidence, or both (and in what order)
- The three c's of cross examination: confirm; confront; complete
- · Impeachment via omission
- Impeachment via prior inconsistent statements
- Verbal and non-verbal cues, including emphasis and modulation
- Looping techniques during crossexamination

### Demonstration #2

Using a sample fact scenario, participants will witness an examination-in-chief.

This evidence will form the basis of your cross-examination in the Part Two small group sessions.

Small Group Sessions – Part Two: DEALING with the DIFFICULT Witness

You'll practice and engage in role plays and drills focused on how to manage un-cooperative and un-responsive witnesses, including:

- Strategies for keeping control of the witness
  - the role of emotions
  - biased witnesses
  - hostile witnesses

### ROUNDTABLE: The Judges' Tell All

In this closing candid session, you'll have the opportunity to hear what the Judges' 'really think'. You will get 'inside their head' and learn what common advocacy techniques work well, and others that are common bugbears.

You'll get invaluable insight and guidance on how to balance being an effective advocate, represent your client resolutely and not compromise your position with the decision makers. Benefit from the insight and perspective of experienced judges.
