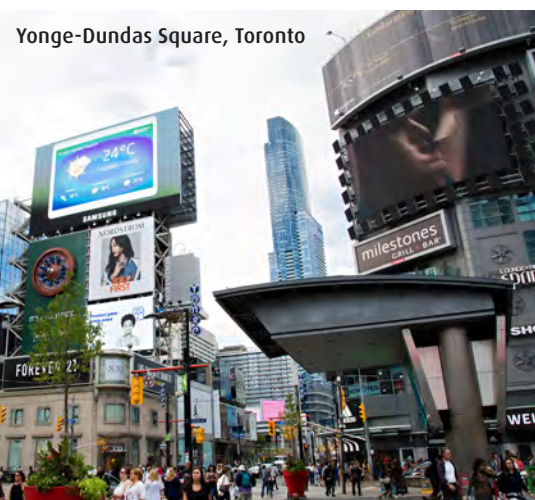

Professional LLM in International Business Law

Program Description

This one-year, full-time specialization is designed to give lawyers and professionals from around the world advanced training in international business law.

Award-winning faculty teach the latest developments in international trade law, international finance, international business transactions, taxation of cross-border transactions and other related topics. The specialization provides students with knowledge in critical, core international business law courses while allowing you the opportunity to pursue your academic interests through electives.

Who Should Apply For This Program?

- Law graduates, preferably with legal practice experience, related work experience or a demonstrated interest in international business law.
- Professionals without a law degree who have at least five years of work experience related to international business law, such as contract management, trade, negotiation, regulation, or governance.

Specialization Structure

The International Business Law specialization is a 1 year full-time program. All courses require in-person attendance and are scheduled in a variety of formats (daytime, evening, weekend and intensive) across both Osgoode Hall Law School and OsgoodePD campuses.

Students can complete their degree requirements exclusively through course work or through a combination of course work and a Major Research Paper. Elective courses can be drawn from Osgoode Hall Law School’s JD specialization and from other OsgoodePD LLM specializations (subject to space availability).

Degree Requirements Overview

36 Credits as Follows:

- Introduction to Canadian Law and Legal Research and Writing for International Students
- At least 21 credits of core courses
- Research Paper Requirement (choice of the following):
 - Significant Research Paper (30 pages) as a form of evaluation in one course; or
 - Independent Significant Research Paper [3 credits] (30 pages); or
 - Major Research Paper [6 credits] (70 pages)

Note: The program starts either in early July or late August depending on whether you are required to take one of our preparatory courses.

Professional LLM in Canadian Common Law

Program Description

The Professional LLM in Canadian Common Law provides the opportunity to take core courses in Canadian common law topics taught at the graduate level along with a wide range of elective options.

The core courses are specifically designed to meet the requirements of the Federation of Law Societies of Canada's National Committee on Accreditation (NCA). Students in the Canadian Common Law specialization benefit from both academic and career support to assist in their transition to the Canadian legal marketplace.

Note: Completing the Professional LLM in Canadian Common Law does not automatically entitle you to practise law in Canada or to be admitted to the Bar of a Canadian province or territory. Consult the NCA or your provincial/territorial law society for more information.

Who Should Apply For This Program?

- Graduates of law degree programs from outside Canada, or graduates with a civil law degree from a Canadian university who wish to become licensed to practise in a Canadian common law jurisdiction, or want a solid grounding in Canadian common law for comparative law purposes.

Specialization Structure

The Canadian Common Law specialization is designed to give full-time and part-time students the flexibility to select courses to fulfil their NCA requirements and fit their schedules.

Courses in the Canadian Common Law specialization require in-person attendance and are scheduled in a variety of formats (daytime, evening, weekend and intensive) across both Osgoode Hall Law School and OsgoodePD campuses. Full-time students complete the specialization in one year (12 credits per term over three terms) and part-time students can complete the specialization over two years (6 credits per term over six terms). New full-time and part-time students are admitted in the Fall and Winter terms.

Students can complete their degree requirements exclusively through course work or through a combination of course work and a Major Research Paper. Elective courses can be drawn from Osgoode Hall Law School's JD specialization and from other OsgoodePD LLM specializations (subject to space availability).

Full-time Professional LLM in Tax Law

Program Description

Knowledge of tax law is essential to any business environment, and the study of this legal specialization is intellectually fascinating.

The Professional LLM in Tax Law offers students an opportunity to gain a deeper understanding of the policies, principles and the internal logic of tax laws in Canada and internationally. It covers all aspects of tax law from the most basic rules underlying traditional personal tax planning principles to current developments in the sophisticated design of financial instruments.

Courses are taught by a diverse range of highly qualified scholars and practitioners, all of whom are leaders in their areas of practice.

Who Should Apply For This Program?

- Law graduates with legal work experience or a strong demonstrated interest in tax law.

- Professionals without a law degree who have at least five years of work experience directly related to tax (such as accounting, finance, trusts) who wish to add a strong advanced foundation in tax law to their professional profile.

Specialization Structure

The full-time Tax Law LLM specialization is designed for full-time students and all courses require in-person attendance. (A part-time version of the Tax LLM is available for those who are working full time). Completed over one full year of study, full-time Tax students complete their degree requirements through a combination of LLM course offerings and upper year JD tax electives. Courses take place at both Osgoode Hall and OsgoodePD campuses to provide students an opportunity to participate in campus life.

The specialization accepts new students every Fall. Students can complete their degree requirements exclusively through course work or through a combination of course work and a Major Research Paper. Full-time students are strongly encouraged to consider completing a Major Research Paper.

Full-time Professional General LLM

Program Description

OsgoodePD's various LLM specializations provide graduate-level learning across a number of disciplines. The General LLM provides students the flexibility to build a specialization from three major areas of interest.

In the Professional General LLM, students can choose courses from multiple LLM specializations being offered during their time of study.

The General LLM provides a high level of customization for lawyers wishing to craft a unique specialization of study drawing from over 50 LLM courses a year.

Who Should Apply For This Program?

Students must have a law degree to be eligible for admission to the General LLM. The General program is most suitable for those who want more flexibility in course options than those offered in a more focused specialization. It is intended for those who already have some legal work experience in the chosen areas of specialization.

Students will have the option to enter advanced courses in their specializations, bypassing any foundational courses in your program. The full-time program is only for students who plan to attend courses in person in Toronto.

Specialization Structure

The Full-Time General Law specialization provides students with the opportunity to build a customized program to meet their professional development goals.

Students take 2-4 courses (12 credits) per term and can select courses from all LLM Specializations excluding Canadian Common Law. The degree is completed over one year (three terms) and requirements can be completed through coursework only or through a combination of coursework and a Major Research Paper.

Graduate Degree Fees and Admission Requirements

Applying to a Graduate Program at Osgoode Hall Law School

Start dates and application deadlines vary by program. Please refer to the individual program page for current start dates and application deadlines.

We recommend that you submit your application well before the deadline, as space cannot be guaranteed and is limited. Graduate program applications are submitted through York University's online application system. Non-degree and preparatory program applications can be done through the International Admissions Office.

Required Application Documents

The application documents listed represent the minimum requirements for graduate degree programs – submitting these documents does not guarantee admission.

Current Resume / CV

- If you have been called to the bar, please indicate the year and jurisdiction.

Personal Statement

- Your personal statement should discuss your interest in the program and how your past studies / related professional experience have prepared you for the program (maximum 500 words in length).
- If you are applying to the General Law program, include your three areas of interest.

Two References

- References may be academic or professional. Recommendation forms must be sent directly from the referee.

Writing Sample

- An academic or professional piece of written work that demonstrates your academic writing ability – critical thinking, research, analysis of at least 5 pages.
- If you are submitting a longer document (i.e. a dissertation) submit an excerpt of approximately 20 pages.
- If you don't have a suitable writing sample, write a brief analytical comment on a legal topic that is of interest to you (preferably related to the specialization in your application).

Tuition Fees for Degree Programs

Domestic Student Tuition:

\$24,132.02 CAD Plus Supplementary Fees

International Student Tuition:

\$35,537.70 CAD Plus Supplementary Fees

Fees include the required course materials. Where assigned, textbooks are provided in hard copy and all other course materials and readings are provided in electronic format only.

Program fees are paid in installments each term:

- Students in the International Business Law specialization pay fees over four full-time terms
- Students in all other full-time specializations pay fees over three full-time terms
- Students in part-time specializations pay fees over six part-time terms

Students who complete the program in fewer terms than the above will have their final installment added at the end of their program. Students who require more than the above will be subject to additional tuition fees.

Academic Requirements

Admissions to LLM specializations at OsgoodePD are competitive. The OsgoodePD Admissions Committee reviews each applicant's file taking into consideration an individual's academic background, professional work experience and fit for the program. The information detailed on the next page, under Academic Background, represents the minimum admissions requirements for graduate degree programs – meeting these criteria does not guarantee admission.

If English is not your first language, you must supply proof of language proficiency. You may be exempted from this requirement if you have completed **at least two years** of full-time study at an accredited university in a country (or institution) where English is the **only** official language of instruction.

Supplementary Fees

Supplementary fees are included in each term's tuition fee installment and are subject to change each term based on approval by York's Board of Governors and in accordance with guidelines set by the Ministry of Training, Colleges and Universities. Additional Fees

- **Registration Fee:** \$15 per term (non-refundable).
- **International Students' Health Insurance:** The University Health Insurance Plans (UHIP) is mandatory for all international students. This does not apply to domestic students. For more information, visit yorkinternational.yorku.ca/current-international-students/health-insurance.
- **Domestic Students' Health Insurance:** Full-time domestic students York University Graduate Students' Association (YUGSA) health plan. The plan is mandatory for all full-time students without comparable coverage for drugs AND dental. The plan is optional for those registered part-time.

Certificate in Foundations for Graduate Legal Studies

Program Description

This program is designed to provide you with the foundation you need for successful graduate legal study. Students in this program:

- Study the foundations of Canadian public and private law in an interactive class setting
- Learn and practise common law legal, analytical and writing skills by building from simple to more complex problems and documents, with opportunity for small group and individual feedback and tutoring
- Lay the foundation for successful performance in LLM courses and in your future legal career

*Please note that completion of this program does not guarantee you admission into any of the graduate degree programs available at Osgoode.

Who Should Apply For This Program?

- Graduates of law degree programs from outside Canada who are interested in pursuing graduate legal studies in Canada
- Professionals without a law degree who have some law-related work experience or education and who are interested in pursuing further education in law

Program Benefits and Structure

The program is full-time and comprises four courses that run between January and May each year. Students attend classes in person at both OsgoodePD and Osgoode Hall Law School campuses. After the intensive two-week orientation course, students can expect to attend class four times per week, for a total of 12 hours, class time weekly. Classes are interactive and are taught by law professors and adjuncts who are practising lawyers from a variety of fields.

Courses and Descriptions

Orientation to Law

This course is a two-week intensive introduction to law school study in Canada and Canadian legal practice. The course introduces students to basic common law concepts and teaches students essential skills such as learning by the Socratic Method, taking lecture notes, reading cases and legislation, preparing case summaries, and engaging in common law predictive analysis.

Throughout the course, guest speakers will be invited in to talk about various areas of legal practice, including litigation practice, corporate practice and government practice. There will be assigned readings, guest speakers, group discussion and tasks, as well as individual written assignments.

Introduction to Graduate Legal Analysis and Writing

This course is designed to familiarize students with core analysis and writing skills. This will involve working extensively with the legal problem solving skills required within a common law regime, becoming familiar with creating commonly used legal documents and academic papers.



The primarily assignment-based nature of this part of the course requires a significant and steady time commitment. The instructors assume that students will approach the course, and the assignments required as part of the course, in a professional manner.

The course will be presented through online lectures and exercises, in-class lectures, discussions, hands-on training sessions, exercises and in-class assignments. Students are expected to do the required readings and complete any assigned quizzes and/or exercises before classes and will be asked to participate in discussions.

Introduction to Canadian Law

This course serves as an introduction to the Canadian legal system. It is intended to provide students a broad understanding of how the law operates in a Canadian context and the conceptual foundation to pursue more detailed studies in Canadian law. The focus of this course is primarily upon Canada’s legal structure and Constitution. Among other topics, the course covers legal tradition, legal theory, sources of law, relationship of various categories of law and the branches of government, court hierarchy, case and statute interpretation and administrative decision making.

Introduction to Private Law in Canada

This course provides students with an introduction to private law in Canada. Through the course students will learn the fundamentals of Canadian tort, contract and property law in common law provinces. This course also provides students with a foundation in Canadian corporate and commercial law.

Eligibility Requirements

If your first language is not English, you must have an English language proficiency test score of at least 7.0 IELTS or its equivalent to be considered for this program. We are seeking participants who have a strong interest in the program and demonstrated academic potential.

Application Documents:

As part of your application, we will ask you to provide the following:

- Copy of language proficiency test results, if your first language is not English (unless you have completed a university degree program at an English-only university)
- Copy of law degree transcripts and any post law degree transcripts; or, if you do not have a law degree, a copy of all university and/or college transcripts
- Current resume
- Personal statement explaining why you wish to join our program and how it will benefit you (500 words maximum)

Program Fees

Domestic Students: \$11,500 CAD

International Students: \$13,000 CAD

Plus material fees and applicable taxes. Fees are due in full prior to enrollment in classes. Fees are subject to change without notice.

Options after Program Completion

Students who successfully complete the program will be issued an Osgoode certificate indicating either a grade of “Pass” or “Pass with Honours”.

A grade of “Pass with Honours” will be awarded to students who:

- Have a sophisticated legal English vocabulary
- Can engage in well-reasoned common law legal analysis
- Can produce the following to at least a B level: graduate-level legal essay, legal memo, case or legislative comment, and response to a lengthy legal fact pattern in an exam environment
- Have minimal grammatical and sentence structure errors in their work
- Are able to make in-class presentations and engage in sophisticated oral legal argument and debate

If you proceed to an OsgoodePD Professional LLM after completion of the program, you may be eligible for advanced standing in the LLM or exemptions from introductory courses, depending on the requirements of the LLM specialization you are entering.

YUELI's Intensive Advanced Legal English Program

Program Description

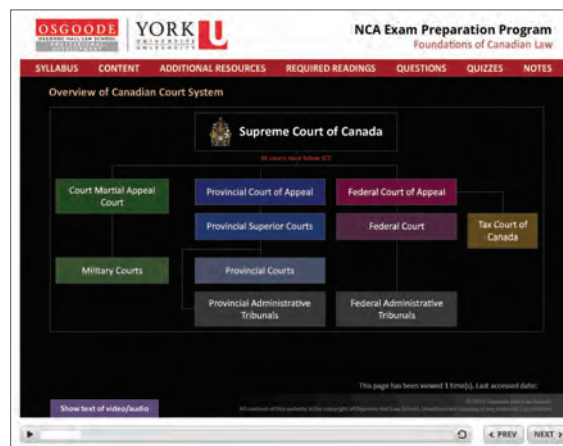
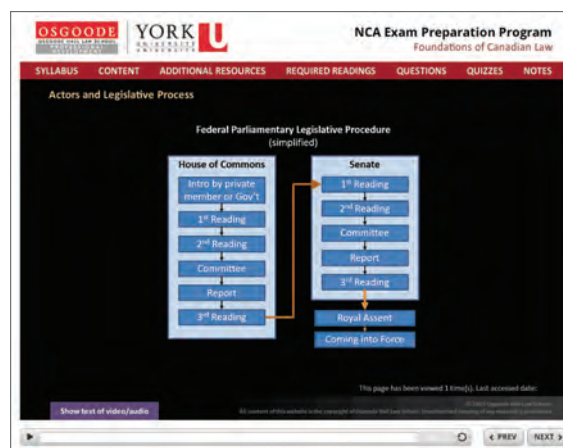

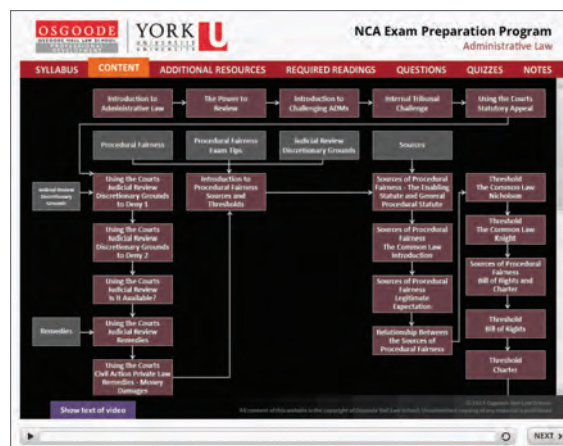
